

RESOLUTION of 4 July 2017, announcing the invitation to tender for contracting, through the pre-commercial public procurement procedure, R&D services within the framework of the first phase of the EMPATTICS project (Empowering Patients for beTTER Information and improvement of the Communication Systems) co-funded by the European Union under the Horizon 2020 program of the European Commission.

2. Purpose of the contract.
